- 1. Check-In
- 2. Review Minute-Taking Schedule for Today's Meeting & Future Meetings
 - a. See Sign-Up Sheet in Committee Team Drive
 - b. All meetings through the end of the semester are accounted for; John asked that Committee members take a look at their schedules for Spring 2019 and sign up to take minutes, when available
 - c. It is highly likely that our Committee meeting scheduled for Monday, December 3 will be a virtual meeting; more details to come via email
- 3. Review & Approve Minutes from September 17, 2018 Committee Meeting
 - a. Minutes reviewed and approved unanimously by Committee
- 4. Update on Committee 2018-2019 Goals:
 - a. John's meeting with Megan Wilson-Reitz re: streaming of University meetings, forums, events, etc.
 - i. John to speak with Chetan Kapoor, John Mack, and/or Jay Tarby re: general IT/privacy capabilities, next steps
 - ii. Idea of creating a Canvas site, accessible to all staff via single sign-on, where video links/streaming can be stored/accessed; this is likely the most secure option available to us
 - 1. We would need to discuss logistics, such as instructions for staff who do not know how to use Canvas
 - 2. Availability to faculty would also need to be discussed, as some University meetings, forums, events include both faculty and staff
 - iii. John to further discuss with the Executive Board the idea of streaming full Staff Council meetings, in addition to All-Staff meetings, beginning spring 2019

- b. Staff Council webpage brief discussion
 - i. Other than minor edits, we will not be making any changes to the current webpage
 - 1. An overhaul of the University's website is expected to take place in the Summer of 2019
 - 2. As such, no major changes will be made until this overhaul occurs
- 5. Assessment (Spring 2019):
 - a. Update on ERG Assessment
 - i. It is too late to move forward with a "pre" assessment of the ERG's
 - ii. Hopefully, we can assess the ERG's in some way come Spring 2019
 - 1. John to discuss this more with Eddie; should the ERG's undergo their own end-of-the-year assessment process, or should assessment of the ERG's be tied to the assessment survey of Staff Council that will be distributed in the Spring?
 - b. Listening Session(s)
 - The first listening session for non-supervisory staff took place on Wednesday, November 7
 - 1. Brenda attended and gave the Committee an overview of what took place and estimated that approximately 20-25 staff members were there
 - ii. John reminded the Committee that a listening session for supervisory staff will take place in the Spring
 - iii. Brandi Mandzak, Vice Chair of Mission & Advocacy, will work with her Committee to compile all data and feedback from the listening session; it will then be shared with our Committee for inclusion in our assessment report
 - c. Survey: How can it be improved this year?
 - John distributed copies of the Staff Council Assessment Survey that was distributed last Spring
 - ii. The Committee reviewed it briefly keeping in mind what may need to be changed, revised, deleted, added, etc. this year
 - d. "Homework:" Review 2017-2018 Assessment Report & 2019 Assessment Survey: what can help us as we dive into assessment in Spring 2019?
 - John asked that the Committee take time to review last year's Assessment Survey, as well as last year's Assessment Report in preparation for the Spring semester
 - 1. What do we want to do again? What do we want to change? What do we want to add or delete?
 - 2. This Committee will dive right into the assessment process, and focus on assessment, when we reconvene in January
